## **March Hare Navigational Rally – 14<sup>th</sup> May 2022** **The 63 Car Club (Elgin) Ltd - Supplementary Regulations**

1. The 63 Car Club (Elgin) Ltd will organise a Clubman permit 12 Car Navigational Rally on Saturday, 14 May 2022 starting from Edinkillie Community Hall, Dunphail, Forres, IV36 2QW.
2. The meeting will be held under the general regulations of Motorsport UK incorporating the provisions of the International sporting code of the FIA, these supplementary regulations and any other written instructions the club may issue.
3. Motorsport UK permit has been issued.
4. The event is open to paid up members of the 63 Car Club and members of the following invited clubs:- HCC, SDMC, ADMC, 750MC, NESMC, Saltire Rally Club and any club that is a member of SAMSC Scottish Association Of Car Clubs.
5. All competitors must produce a valid membership card and minimum Motorsport UK Clubman RS Licence.
6. The event is a round of the 63 Car Club O/A & Rally Championship, North East Scotland Motor Club Championship and the Scottish Navigational Rally Championship.
7. The programme of the meeting will be:
  - Scrutineering & Noise Tests opens: 19:45**
  - Signing on opens: 19:45**
  - Car 1 Starts: 20:41**
8. The latest edition of the **Ordnance Survey Landranger Sheet 27, Nairn & Forres** map is required. Any feature of the map or legend may be used to define the route taken.
9. The event will consist of Expert, Non Expert and Novice Classes. All vehicles must comply with Motorsport UK Technical regulations and all cars must be taxed and have a current MOT certificate. The maximum number of entries is 12, the minimum is 6.
10. The entry list opens on 30<sup>th</sup> April 2022 and closes finally at 21:00hrs on Tuesday 10<sup>th</sup> May 2022. All entries must be made on official online entry forms. The entry fee will be £20.00 payment details will be on entry form.

13. Provisional results will be published ASAP after the event. Protests to be made accordance with C5.1.2 to 5.2.3.
14. Entrants will be supplied with a route card / time card at the start and as required during the event. These documents provide all the information necessary to comply with R 6.2.9 to 6.3.1.
15. Competitors will be identified by numbers, which will be supplied. These should be displayed at all times in the window behind the navigators door.
16. Marking and penalties will be as the Motorsport UK General Regulations except;
  - R Chart 13 (d)** 15 marks
  - R Chart 13 (e)** 300 marks before scheduled time, 2 marks if before due time.
  - R 11.3 to 11.3.3** Code boards will be used to ensure compliance with the correct route. Sample boards will be displayed at the start
  - R 15.2.2** In the event of a tie, results will be by furthest clean basis, if tie remains then navigation test will be used.
  - R 11.1.1** Competitors will not be penalised for stopping within sight of a control. They may wait in the control until their due time.
17. In Quiet Zones marked QZ START, competitors must drive quietly using no auxiliary lights. All 30 and 40 mph limits are deemed to be quiet zones.

18. The Organisers have applied to Bluefin Sport for a Blanket Cover Note under the above scheme. This will provide competitors who need to use the scheme with the Third Party Cover necessary to meet RTA requirements on the Road Sections of the event.

All applicants wishing to use the scheme must be able to comply with all points of the Bluefin Sport Declaration:

- I do not have the Third Party Road Section extension on my current Motor Insurance.
- I am aged 19 or over.
- I have had no more than 1 fault claim in the last three years.
- I have no more than a maximum of 6 conviction points or a licence ban on my UK driving licence.
- I have the appropriate competition/club membership licence as well as a UK/EU driving license and if my license is provisional I will be supervised by an adult over 25.
- I have no physical or mental disabilities.
- My vehicle is MOT'd, Taxed and Insured for the road.
- I have no other material facts to disclose.
- Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

If you comply with all points above no Letter of Acceptance will be required. If unable to comply with any of the above points you will be required to complete the Declaration form (the form can be obtained by contacting the event secretary or Bluefin Sport) which should be forwarded either to the organisers or direct to Bluefin Sport prior to the event to allow sufficient time for a letter of acceptance to be issued.

20. The correct route will be the shortest route at all times whilst complying with organiser's instructions. Straight on is implied at all times unless otherwise stated. The total mileage will be approximately 80 miles. Fuel will not be available at the start. The nearest petrol stations are Nairn, Forres or Elgin.
